

The event is convened in Bogotá, Colombia, by the United Nations University World Institute for Development Economics Research (UNU-WIDER) in partnership with Universidad de los Andes (UNIANDES). The vision of the African Research Universities Alliance (ARUA) is "to strengthen African universities through effective capacity building that comes from working together with a view to increasing significantly their research output". As an ARUA centre of excellence, capacity building through collaboration is one of the core prongs of ACEIR's work. During the past two months, four capacity building workshops were hosted for and by ACEIR researchers in collaboration with DataFirst; the Bristol Poverty Institute, University of Bristol; and the Agence Française de Développement.

NEWS | Exploring collaboration on global gender equality research project

Preceding the data training workshops was another knowledge exchange by invitation from Prof Gordon to the ACEIR team. Hosted by the Stellenbosch Institute for Advanced Studies as part of their seminar series, it entailed a talk on a new research collaboration on Advancing Gender Equality in Africa and Globally: Strengthening Health and Economic Outcomes by Learning What Works at Scale. This project will bring together an international, interdisciplinary team to develop the evidence on what works at scale by using longitudinal data to evaluate rigorously how national laws and policies focused on gender equality affect health and economic outcomes for women, men, and children across countries.

Prof Gordon presented this initiative together with Dr Amy Raub, WORLD Policy Analysis Center, University of California; and Dr Jody Heymann, WORLD founding director. This

work will also emphasise knowledge translation and mentorship of junior scholars with the goal of moving from evidence to impact. A team of ACEIR researchers who are interested in collaborating on this project have since met with Prof Gordon and colleagues to explore options to join projects on this important work.


NEWS | Inequality diagnostics training for Mali team



With a small team of French-speaking researchers embarking on an inequality diagnostic for Mali, a training workshop was hosted recently to orient them in the use of a key tool that guides the production of ACEIR's inequality country reports. The tool, the *Handbook on Inequality Measurement for Country Studies*, was developed by researchers from ACEIR's South Africa node. It has been used to guide research teams when they produced the first three African country reports on inequality trends in Ghana, Kenya, and South Africa, respectively. As with these three diagnostics, the Mali report will also be completed in collaboration with the Agence Française de Développement.




HIGH-LEVEL POLICY DIALOGUE ON INEQUALITY: Developments and nallenges in st-COVID Environment

International Monetary Fund policy dialogue on inequality

Prof Robert D. Osei was one of the eight presenters at this high-level policy dialogue which dealt with "Developments and policy challenges in the post-COVID environment" in the context of increasing income inequality and food and fuel price shocks due to the Ukraine war. Discussing these developments, the potential policy responses; and their implementation in a very complex and tight policy environment, the event focused on sub-Saharan Africa and with discussions about the Latin America responses. Prof. Osei's presented on "Sub-Saharan Africa: Inequality developments and description of policy responses in the region".



Human Development & Capability Association annual conference

"Is inequality a political choice?" was the provocative title of the closing plenary of the HDCA's 2022 conference, held in Antwerp, Belgium. The discussions were framed by the latest *World Inequality Report* of the World Inequality Lab, Paris School of Economics.



Arguing that "inequality is always a political choice", the report focuses especially on policies with the potential to combine wealth redistribution and investment in a more just and sustainable future. Reflecting on these talking points in the South African and African contexts was ACEIR director, Prof Murray Leibbrandt, from the Southern Africa Labour and Development Research Unit, University of Cape Town. He pointed out that the lack of implementing structural economic reforms (including land, tax and social security reforms) is maintaining economic inequalities. Wealth inequality exacerbates the situation as it results in multiple income sources for those in the wealthiest segments of the population.

Workshop on gender inequalities and economic theory and policies for a postpandemic world

Prof Abena D. Oduro delivered the keynote at this workshop organised by the Levy Economics Institute of Bard College. Two colleagues from the University of Ghana who are part of the ACEIR team also made presentations at the three-day event in September 2022. Addressing the session on "Identifying gender inequalities in sub-Saharan Africa" was Dr Nkechi S. Owoo, who presented on "Women's time poverty and non-adult supervision of children in Ghana". Dr Monica Lambon-Quayefio spoke at the session on "Gendered paid and unpaid labour in sub-Saharan Africa" where she presented on "Child care and firm outcomes of female entrepreneurs: Empirical evidence from Ghana". Dr Lambon-Quayefio was also a discussant at the session on "Gendered aspects of Latin American labour market".
